ENTRY REQUIREMENTS

Participant must:

- 1. Hold a Car Driver Licence (No P's or L's)
- Under go a medical examination for Commercial Vehicle Drivers
- Provide a driving history report from the appropriate road authority.
- 4. Have reasonable English literacy skills
